## Town of Lochbuie Election - coming up November 6, 2018

The Town of Lochbuie will be accepting nominations for candidates for Mayor and three (3) Trustee seats. The nomination petition form can be picked up beginning **Tuesday, August 7, 2018** at the Town Administrative Offices, 703 Weld County Road 37, Lochbuie, CO 80603. The nomination petition must be returned to the Town Clerk signed by a minimum of 10 registered electors residing in Lochbuie no later than **Friday, August 27, 2018**. Requirements for these positions include:

- Registered elector in the Town of Lochbuie
- Must be at least eighteen (18) years of age or older on the date of election
- Must have resided within the Town of Lochbuie for a period of at least twelve (12) months prior to the date of election

The Town Board of Trustees meets regularly on the first and third Tuesday of each month at 6:30 PM at Town Hall and there are additional meetings scheduled from time to time. The election will be conducted in coordination with Weld County as a mail ballot election so the Town election ballot will be part of the large ballot you receive from the County.
